# Why is College Accreditation important?

- An indication for quality learning programs and services
- Students eligible for financial aid
- College eligible for federal/state grant funds
- Students' earned academic units/certificates/degrees could transfer to 4year colleges and universities and/or for employments
- Etc.



The ACCJC is authorized to operate by the U.S. Department of Education through the Higher Education Opportunity Act of 2008.

The ACCJC accreditation process provides assurance to the public that the accredited member colleges meet the Standards; the education earned at the institutions is of value to the student who earned it; and employers, trade or profession-related licensing agencies, and other colleges and universities can accept a student's credential as legitimate.

## Educational Quality and Institutional Effectiveness

6-year cycle - Accreditation 4 Major Steps:

- Internal evaluation self study (For BCC, now!)
- 2. External evaluation 2015
- Commission review
- Continuous institutional improvement the college needs to comply with eligibility requirements, accreditation standards, commission policies at all times – not just immediately before or after an accreditation review.


#### **Accreditation Standards**

- Institutional mission and effectiveness, and improving institutional effectiveness
- Student learning programs and services: instructional programs, student support services, library, and learning resource services
- Resources: human, physical, technology, and financial resources
- Leadership and Governance decision-making roles and process, Board and administrative organization.

### Principles Supporting Self Evaluation Process

- Address and meet eligibility requirement, accreditation standards and policies
- Provide supporting content and evidence
- Provide and analyze existing evaluation, planning and improvement data
- Apply assessment findings to plan and implement improvement plans
- Involve relevant stakeholders who have a role in improving institutional quality.
