A. Community for A Cultural Civic Center Presentation (Senator Mazariegos | Discussion | 15 Min)

- a. The ASBCC will hear a presentation about the mission of CCCC, their website, and their progress to date.
- b. CCCC is working to redesign the park north of Berkeley High, surrounded by historic buildings
- c. CCCC consists of Berkeley people looking to make the area around City Hall the best it can be for the community
- d. Old City Hall is currently only used by one nonprofit, on the verge of collapse
- e. Veteran's building, built in 1928, to commemorate the Civil War, Spanish American War, and WWI. Now under demolition for neglect too
- f. City hired an international design firm, whose recommendations seem vague
- g. CCCC is a city advocacy group essentially, now raised some funds to do a realistic seismic cost analysis.
- h. CCCC is inviting students interested in city planning to help with the process; go on tours of the buildings
- i. There will be a bond issue with the city in 2022.
- j. Next 6 months - start the realistic seismic study. Range of earthquake risk is in the middle between collapse immediately and still being up as people run out
 - i. Cost analysis done by next summer
 - ii. Need to get with city council & boards to advocate that the CCCC advisory group gets added in the bond.
- k. Ask Sergio for interest to tour in early May

- a. The ASBCC council will hear updates on the AAC and offer suggestions.
- b. Senator Mazariegos proposed a format for the commission for the current group
- c. structural changes will be minor from now on

 - i. Executive - only has tiebreaking voting power
 - ii. Research committee - research currently available resources at BCC and seek out new resources; represent students who may shy away from speaking up
 - iii. Outreach committee - ensures everyone at BCC knows the available resources; social media posts prepared far in advance
 - iv. Academic Integrity branch - trickiest, deal with student privacy and AP5500; figure out what the council can do in a case of academic dishonesty; aim to focus on restorative approach rather than penal; acts as intermediary between students, faculty, and admin during investigations
- f. Right now, most important objectives are to 1) figure out logistics behind codifying the AAC into the constitution/bylaws; 2) gather student input on the mission & implementation of the commission
