A. HEERF Presentation (Martin De Mucha Flores | Discussion | 15 Min)

a. The ASBCC will hear a presentation about the Higher Education Emergency Relief Fund.

Martin de Mucha Flores & Stacy Shears (VP Student Services)

- Here to give feedback and share about the use of HEERF.
- Slide show presentation given
- On a messaging campaign
- HEERF is a \$14 billion fund from the CARES Act
- Benefits available to more than just financial aid students.
- They are looking to maximize the benefits students receive.
- Create safe facilities, student and educational support.
- HEERF I Funds posted to BCC in May and July 2020
- HEERF II are accessible to BCC
- Student payments are being pushed out at the end of the month.
- Expenses are restricted and student funds must go directly to students. The student decides how to use the funds. For example-DREAMers can receive student funds.
- Institutional restrictions are restricted to services that address distance learning and the pandemic
- BCC is receiving \$4.2 million
- BCC increased student aid beyond the required minimum from \$922,262 to \$1.7 million

- Senator Singh asks if students who were unaware of the funds can still access them.
 - VP Shears- BCC received information from the district and identified students with need. There is no application process.
 - Students may ask their financial aid advisor if they received HEERF funds.
 - Back-Funding is a possibility if students were overlooked.
 - VP Bui brought up the transportation issues students face and how ASBCC approved funds to purchase clipper cards and that other groups have also allocated similarly. VP Bui asks if HEERF funds can be used for transportation needs.
 - VP Shears said there is no plan but that she and VP Flores are at the meeting to receive this type of feedback.

B. Temporary Transition Committee Approval (Senator Mazariegos | Discussion & Action | 10 Min)

- a. The ASBCC will discuss the formation of the Transition Committee, with aims to better prepare the incoming ASBCC officers for their term next academic year.
