Independent Study In response to Barbara Des Rochers question of whether the rumor that the state is no longer approving independent study courses (049s), co-chair Krupnick recently sent the question out to a state-wide listsery for curriculum chairs to see if anyone knows the answer.	needs to be added to the list of pre-requisites for ENGL 1A. In addition, there is discussion about removing a very old pre-requisite ESL 021B. The committee gives approval for updates to ENGL 1A pre-requisites when determined districe-wide what these will be. 	B. Tech Review The next curriculum committee meeting is not until 4/12 for tech review. Cochair Krupnick requested that committee members complete their tech review well in advance of that date so that if there are any areas that need to be addressed, the multimedia faculty can do so before tech review. C. It was announced that there is a rumor that due to AB 705, the state may require all students to start in ENGL 1A (with a co-requisite if needed) unless the college can prove that the student is not ready for the course. Currently about 80% of our students do start with ENGL 1A. The 20% who do not start there, really need that additional work to prepare.	B. Please do tech review early.
