IV. DE Addendum Examples from Other Colleges	C. Bernard provided text from Title 5 section 55206, showing changes to DE. He also provided samples of DE addendums from the College of the Redwoods, De Anza, Santa Barbara City College, and Laney. What is the curriculum committee's role as a result of this change? In addition to the usual determination of whether a course is suitable for online education, there appears to be more needed. We could make DE consultation similar to the Library consultation. This would have the added benefit of ensuring that faculty understand the requirements of teaching online, such as accessibility. It was noted that previously in Canvas there was an accessibility check which gives instructors feedback about their site. That could be reinstated.  The committee must determine if the current DE section of the outline meets the requirements. If not, a change to the outline would have to be agreed upon district-wide.	There was a request to see the accessability checklist from College of the Redwoods.  Student to student contact needs to be added to the drop down menu in Curricunet.  Ari will bring this DE for discussion to CIPD or a post-CIPD meeting with the curriculum reps from the district.
