California Students Vote Project Overview

California Students Vote Project

Established in 2016, the California Secretary of State (SOS) Students Vote Project (SVP) is a statewide nonpartisan program that elevates college student voices and promotes civic engagement efforts to build a more inclusive democracy. Through the creation of the Students Vote Project, California was the first state in the nation to build partnerships across the state's major higher education systems to empower students to participate in the democratic process. Program objectives include increasing college student voter education, voter registration, and outreach. The SVP achieves these objectives by hosting civic engagement events, creating educational resources, and partnering with campuses and outreach organizations.

Student Civic and Voter Empowerment Act (SCVEA)

In 2019, the Student Civic and Voter Empowerment Act (<u>California Education</u> <u>Code §66850-66852</u>; <u>California Elections Code §2148.5</u>) was enacted to give California colleges and universities the necessary tools to increase civic engagement and participation among young voters. In 2020, the California Secretary of State Students Vote Project was expanded to support and ensure implementation of the landmark law. The law requires the California SOS to work directly with the California Community Colleges (CCCs) and California State Universities (CSUs) to increase college student voter registration. Colleges and universities are encouraged to participate in SVP civic learning opportunities to receive and distribute voter education resources. While the University of California (UC) and the Association of Independent California Colleges and Universities (AICCU) campuses are not required to participate, they continue to be strong partners and supporters of student civic engagement.

What is Proposition 50? Put on the Ballot by the Legislature

Proposition 50 (Prop 50) seeks to replace California's current congressional district maps with new legislatively drawn maps. If Prop 50 passes, the state would use Prop 50's maps for congressional elections starting in 2026. The state would use these congressional maps until the California Citizens Redistricting Commission (Commission) draws new congressional maps, following the 2030 U.S. Census.

What Does a YES Vote on Prop 50 Mean?

A **YES** vote on this measure means: The state would use new legislatively drawn congressional district maps starting in 2026. California's new congressional maps would be used until the Commission draws new maps following the 2030 U.S. Census.

What Does a NO Vote on Prop 50 Mean?

A **NO** vote on this measure means: Current congressional district maps drawn by the Commission would continue to be used in California until the Commission draws new maps following the 2030 U.S. Census.

- Monday, October 20: The last day to <u>register online to vote</u> for the November 4, 2025, Statewide Special Election.
- Tuesday, October 21 Tuesday, November 4: <u>Same Day Voter Registration</u> (Conditional Voter Registration) is available. Voters can use the Same Day Voter Registration process during this time.
- Saturday, October 25: Vote centers open for early in-person voting in all Voter's Choice Act counties.
- Tuesday, November 4: Election Day Polls are open from 7:00 a.m. to 8:00 p.m.
 - Vote-by-mail ballots must be postmarked on or before Election Day and received by November 12, 2025.

Make a Plan to Vote **College Student Voter Checklist**

The deadline to register online to vote or update your registration is **Monday, October 20**, **2025.** Make sure you are prepared to vote on Election Day, **Tuesday, November 4, 2025,** by completing the college student voter checklist below.



Register to Vote

 Register to vote or update your voter registration information as early as possible at https://registertovote.ca.gov/collegestudents to ensure your vote-by-mail ballot is sent to the correct address.



Choose How You Will Vote:

- Vote by Mail: Every active registered voter will receive a vote-by-mail ballot for the November 4, 2025, Statewide Special Election. Voting by mail is a safe and secure way to return your ballot.
- Vote in Person: In person voting locations offer important resources such as Same Day Voter Registration, ADA accommodations, replacement ballots, and other support in various languages.



Identify When and Where You Will Vote:

- Early in Person: All counties in California offer early in-person voting opportunities; visit https://caearlyvoting.sos.ca.gov to find your nearest vote center or polling location.
- Early by Mail: Mark your ballot, sign the ballot return envelope, and place it in the mail early. Vote-by-mail ballots must be postmarked on or before Election Day and received by November 12, 2025.
- Secured Drop Box: Mark your ballot, sign the ballot return envelope, and place it in a secure drop box no later than 8:00 p.m. on Election Day. The secure drop box are clearly and visibly marked as an "Official Ballot Drop Box" that shows language stating that tampering with the drop box is a felony.
- **Election Day:** Polling locations and vote centers will be open from 7:00 a.m. to 8:00 p.m. on Election Day. If you are in line by 8:00 p.m., then you have the right to vote. Stay in line until you are able to cast your ballot. For more information, view the **Voter Bill of Rights**.
