## BCC Areas of Focus

1. Infrastructure Capacity Building for use of data focused on Equitable Student Outcomes

- Build capacity in the **IR Office** for increased data analysis and systems revisions
- Facilitate, guide, and support faculty and classified professionals to make **necessary programmatic and service revisions that lead to equitable outcomes** (e.g. , APU/CPR revisions, BPAs for Guided Pathways implementation)
- Identify, record, analyze, and **action plan to address students' experience of BCC** and key areas of challenges and institutional barriers that inhibit their progress
- Facilitate and support professional development for teaching & learning with faculty and classified professionals, including but not limited to **New Faculty Academy, Adjunct Faculty Symposium, Classified Professionals Symposium.**




## IEPI- Preparation for Visit #2

- Based on the documentation review, interviews, meetings, further discussions, and their own collective expertise, the PRT creates a ***List of Primary Successes and Menu of Options (MOO)*** for consideration by the institution as it develops its **Innovation and Effectiveness Plan (I&EP)**. The MOO consists primarily of ideas for improvement and/or best practices, along with references and models or examples of applicable practices successfully used at other institutions, in each Area of Focus. At least a week before the second visit, the PRT Lead sends this document to the CEO and point persons for review. The CEO reviews it, and if any tweaks are in order, suggests them to the Lead, who incorporates them as appropriate and sends the final to the CEO and point persons for distribution to the I&EP Drafting Group, which should read it carefully and, if feasible, meet to discuss it prior to Visit 2.

- **Invitation** to have a representative from the various constituency group leads compose the membership of this writing group.
  - Review the Summary of Visit and Menu of Options
  - Co-create the BCC Innovation & Effectiveness Plan based on the summary and recommendations by the Partnership Resource Team
